Regular Gifts

Regular gifts allow Development Nepal and our partners to plan for the future. Please complete the Regular Gift section of the Donation Form if you would like to set up a regular gift to Development Nepal. If you are a UK taxpayer and would like Gift Aid to be applied to your regular gift, please sign the Gift Aid declaration (see Gift Aid notes below).

Gift Aid

Standard Rate Income Tax

All donations made by UK taxpayers are eligible for Gift Aid status. Using Gift Aid means that for every pound you give, we get an extra 28 pence from the Inland Revenue, helping your donation go further. You must pay Income Tax and/or Capital Gains Tax equal to the tax Development Nepal reclaims on your donation in the tax year. Please remember to notify us if your circumstances change.

Gift Aid and Higher Rate Income Taxpayers

If you are a higher rate taxpayer, you can claim back the additional higher rate tax on your own tax return, which further reduces the cost of making a donation. Since the 6th April 2004, you can also nominate Development Nepal to receive this higher rate relief.

On your Self Assessment Tax Return, you must fill in answers to Question 15A, giving details of all your donations to charities. You then need to answer Questions 19 & 19A and B to give any repayment resulting from the higher rate relief to Development Nepal. You can also elect to make any repayment to us eligible for Gift Aid. The Inland Revenue sends your higher rate relief to our bank. We are then able to enter this on our records as a donation and claim the additional Gift Aid. Here is an example of how this works in practice:

Cancelling your Gift Aid Declaration

Please notify us if your circumstances change and you no longer pay tax on your income and/or capital gains equal to the tax we reclaim. You can cancel your Gift Aid declaration at any time by notifying us.

Giving Via CAF or a Trust

Some donors have a CAF (Charities Aid Foundation) Account, or their own personal Charitable Trust, and can reclaim income tax at either the basic or higher rate in order to increase the amount they give.
